## Rebuilding Together Seattle



**A Call for Applicants!** [Rebuilding Together Seattle](#) (RTS) brings volunteers and communities together to help low income homeowners live in warmth, safety and independence. RTS serves low income homeowners who are elderly, disabled, families with children, and/or veterans in need.

The RTS office has begun the process of planning for their Spring programs, including their 24th Annual Spring Rebuilding Day (Saturday, April 26, 2014), where they hope to help 27 homeowners in the greater Seattle area with the support of over 1,000 volunteers. They also hope to help 30 more families through their year-round maintenance program, Safe at Home, and 16 more families through their Team Build program by June 30th. They are currently accepting applicants to consider for all of their programs.

While Rebuilding Together Seattle accepts applications year round, they are requesting that interested homeowners apply ASAP or by **January 17, 2014** to be considered for their Spring programs.
